In 2019, John received the Deputy Alan Hultgren Meritorious Service Award. For his entire career John has been a positive example of law enforcement. He has trained and mentored many and he is a true friend. For medical reasons, John resigned from the position of patrol deputy and has taken on a new assignment at the Skagit County Community Justice Center. John is a positive image that represents the SCSO for visitors and staff at our jail. He will still be called upon to help train deputies well into our future.

Deputy John Hendrickson has been a positive image of law enforcement within Skagit County and when he represents us within other jurisdictions. He has been a positive influence and a mentor for so many in law enforcement.
